

**SEVENTH AMENDMENT TO
LUMEN MASTER SERVICE AGREEMENT
STATE, LOCAL AND EDUCATION GOVERNMENT AGENCIES VERSION**

This Seventh Amendment to Lumen Master Service Agreement - State, Local and Education Government Agencies Version (this "Seventh Amendment") is between **CENTURYLINK COMMUNICATIONS, LLC DBA LUMEN TECHNOLOGIES GROUP**, ("LUMEN" or "CONTRACTOR") and **MARION COUNTY, A POLITICAL SUBDIVISION OF THE STATE OF FLORIDA** ("CUSTOMER" or "COUNTY") (each, a "Party" and together, the "Parties"). It amends the Lumen Master Service Agreement - State, Local and Education Government Agencies Version executed by the Parties on or about December 23, 2020, as previously amended (the "Agreement" or the "MSA"). This Seventh Amendment is effective on the date the last Party signs it (the "Amendment Effective Date"). This Seventh Amendment modifies pricing in the Agreement and adds the Marion County Standard Additional Terms and Conditions (the "ATC") to the Agreement, attached hereto and executed contemporaneously herewith. Except as set forth in this Seventh Amendment, capitalized terms will have the definitions assigned to them in the Agreement or the ATC. The pricing modifications shall be considered an offer by CONTRACTOR, which may be withdrawn if CUSTOMER does not execute and deliver this Seventh Amendment to CONTRACTOR on or before May 31, 2026 ("Cutoff Date").


1. This Amendment is between Lumen and **MARION COUNTY, A POLITICAL SUBDIVISION OF THE STATE OF FLORIDA** ("Customer") and modifies Order No. **DOC-0001693317, DOC-0001681345, and Quote 12914310** that Customer is executing and delivering contemporaneously with execution of this Amendment and is attached to this Amendment. This Amendment is effective on the date the last party signs it. Except as set forth in this Amendment, capitalized terms will have the definitions assigned to them in the applicable underlying Agreement.

2. Modifications to Terms. The terms of the Agreement and this Seventh Amendment shall be governed by the ATC, which shall take precedence and be controlling over any conflicting terms in the Agreement.

3. Miscellaneous. All other terms and conditions in the Agreement will remain unchanged, in full force and effect, and be binding upon the Parties. This Seventh Amendment and the Agreement set forth the entire understanding between the Parties as to the subject matter, and if there are any inconsistencies between the two documents, the terms of this Seventh Amendment will control. This Seventh Amendment may be executed in one or more counterparts, all of which taken together will constitute one instrument. Digital signatures and electronically exchanged copies of signed documents will be sufficient to bind the Parties to this Seventh Amendment.
