

FIRST AMENDMENT TO THE AGREEMENT

In accordance with the Photography Services Agreement entered into on July 18, 2023, and all of its amendments (if any), collectively (the “Agreement”) this First Amendment to the Agreement (this “Amendment”) is made and entered into by and between **Digital Fury, LLC**, whose address is 3440 S.E. 45th St., Ocala, FL 34480; possessing FEIN 45-3141493, (hereinafter referred to as "FIRM") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as “COUNTY”).

WITNESSETH

WHEREAS this Amendment shall remain in full force and effect until completion of all services required of FIRM, and the parties wish to amend the Agreement.

IN CONSIDERATION of the mutual covenants and conditions contained herein, COUNTY and FIRM (singularly referred to as “Party”, collectively “Parties”) hereto agree as follows:

1. This Amendment shall be deemed to amend and become part of the Agreement in accordance with project 23P-082, (the “Project”). All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
2. The Parties mutually acknowledge that Digital Fury, LLC and MAVEN Photo and Film LP will work collectively in their respective roles to complete four (4) episodes of the Marion Insider Guide.
3. Currently, FIRM provides Photography Services for COUNTY as described in the Photography Services Agreement under Exhibit A – Scope of Work. This Amendment adds the below tasks to be performed by Digital Fury, LLC; the remaining tasks will be performed by Maven Photo and Film LP to complete four (4) episodes of the Marion Insider Guide.

4. The total cost for Digital Fury, LLC’s portion of the project will not exceed Forty Thousand, Seven Hundred Dollars (\$40,700) (the “Agreement Price”).
5. The term shall commence upon Board approval and shall continue through August 1, 2024 (the “Term”)
