**Item 8.1. SUBJECT: Request Board Approval for Transfer and Assignment of Waste Hauler Franchise from Florida Express Environmental, LLC, to Waste Connections of Florida, Inc.**

The name of the solid waste hauler was incorrectly referenced as “Florida Environmental Express, LLC” in the second and fourth Whereas clauses in the Resolution. The name has been corrected to “Florida Express Environmental, LLC”.

## **RESOLUTION NO. 25-R-\_\_\_\_\_**

### **A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA, APPROVING THE TRANSFER OF A SOLID WASTE HAULER FRANCHISE FROM FLORIDA EXPRESS ENVIRONMENTAL, LLC, TO WASTE CONNECTIONS OF FLORIDA, INC.; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS** Florida Express Environmental, LLC, a current solid waste hauler franchisee in good standing, has submitted a request to transfer its franchise to Waste Connections of Florida, Inc., pursuant to Section 16-50 “Transfer of Franchise,” of the County Code; and

**WHEREAS**, Waste Connections of Florida, Inc. is the holder of a current solid waste hauler franchise, and thus is qualified to be the transferee of the Florida Express Environmental, LLC, franchise under Section 16-50; and

**WHEREAS**, the Board has determined that the other requirements of Section 16-50, specifically the satisfaction of all accounts payable to Marion County from Florida Express Environmental, LLC, have been satisfied; and

**WHEREAS**, Waste Connections of Florida, Inc., has advised the Board that its intent is to continue to operate the transferred franchise under the name of Florida Express Environmental, LLC.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Marion County, Florida:

**SECTION 1.** The Board finds that the requirements of Section 16-50 of the County Code have been satisfied for the requested transfer.

**SECTION 2.** The Board hereby approves of the transfer of the solid waste hauler franchise from Florida Express Environmental, LLC, to Waste Connections of Florida, Inc., which shall henceforth be subject to compliance with the requirements of that franchise and the County Code.

**SECTION 3.** Waste Connections of Florida, Inc., may continue to operate the transferred franchise in the name of Florida Express Environmental, LLC.

**SECTION 4. EFFECTIVE DATE.** This Resolution shall take effect immediately upon its adoption.
