## TASK ORDER TO THE AGREEMENT

In accordance with the Geotechnical Engineering Services Agreement, approved by the Board of County Commissioners on October 17, 2023 (the "Agreement") for work within the scope of Solicitation 22Q-228-TO-11 Geotechnical Services for Florida Crossroads Commerce Park & Segment F Construction Project, this Task Order to the Agreement (this "Amendment") is made and entered into between Central Testing Laboratory, Inc. whose address 130 Satellite Court, Leesburg, FL 34748, and possessing FEIN# 59-3638395 ("CONTRACTOR") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471 ("COUNTY").

## WITNESSETH

WHEREAS the parties wish to amend the Agreement as set forth below; and;

IN CONSIDERATION of the mutual covenants and conditions contained herein, the parties do hereby agree as follows:

- 1. This Amendment shall be deemed to amend and become a part of the Agreement in accordance with the original Solicitation and Agreement for Geotechnical Engineering Services under 22Q-228.
- 2. CONTRACTOR's services and performance will be in accordance with the Scope of Work, Exhibit A hereto. The total cost for the Project shall not exceed Two Hundred Twenty-Two Thousand Seven Hundred Fifty-Four Dollars and Nine Cents (\$222,754.09), or two percent (2%) of the total construction cost, whichever is less. The Geotechnical Work shall be performed continuously throughout the duration of the Construction and shall not be deemed complete until the Project has achieved Final Completion. All Work shall proceed in a timely manner without delays. **TIME IS OF THE ESSENCE.** All limitations of time set forth in the Contract Documents are of the essence of this Contractor. The Work may be presumed abandoned after ninety (90) days if CONTRACTOR terminates the Work without just cause or without proper notification to COUNTY, including the reason for termination, or fails to perform Work without just cause for ninety (90) consecutive days.
  - 3. All provisions of the Agreement not specifically amended herein shall remain in full force and effect.

## Exhibit A – Scope of Work 22Q-228-TO-11

The FIRM shall provide field and laboratory testing services to ensure road construction materials and workmanship comply with project specifications, FDOT, ASTM, AASHTO, and other applicable standards. Services will include testing of soils, base materials, asphalt, and concrete for properties such as compaction, density, thickness, strength, and smoothness. Test reports and certifications will be provided to document compliance, along with recommendations for corrective actions when needed. Testing will be performed as required throughout the duration of construction and coordinated with the project schedule.

These services are in coordination with 25B-123 Florida Crossroads Commerce Park (SW 145<sup>th</sup> Place Rd.) & SW 49<sup>th</sup> Ave Segment F.
