### **2. SCHEDULED ITEMS**

#### **2.1 Workshop: Discussion for Proposed Marion County Land Development Code (LDC) Amendments Presented by Staff. The LDRC will Review and Provide Recommendations Regarding Section 4.3.30 Smoke Shops**

Ken Weyrauch, Growth Services Deputy Director, opened the discussion regarding this item. Chief Assistant County Attorney Dana Olesky added additional comments.

  - Clarified that there are currently 140 to 170 child care facilities in Marion County.

The following member of the public spoke during Public Comment:

1. Mary DelZotto – 5050 NW 150<sup>th</sup> Avenue, Morriston
  - Expressed concerns about the restroom facilities intended for employees only, or are they also available for public/guest use? If a restaurant removes its kitchen operations from inside the main building and instead operates from a food truck positioned behind the establishment, does this arrangement fall under the same rules and requirements as standard food trucks? In cases where equipment or structures (such as a food truck or portable kitchen setup) are temporary or removable, how are they classified for regulatory or compliance purposes?

The Board agreed that more discussion on the language was needed and will bring the item back to a future Workshop.
