**Addendum to Member/Alternate Member Application to the County Advisory
Committee Land Development Regulation Commission**

Following 52 years in the industry, I retired at the end of 2024 as the founder/owner/operator of a multi-million-dollar international nuclear consulting firm. The company's focus was primarily on innovative strategy development and planning for managing liquid and solid waste streams, and hazardous material site remediation with a focus on environmental restoration. Those efforts required engagement with domestic and international clients, local, state and national regulators, international agencies, and local populations. I have authored or co-authored several hundred related strategy and technical documents and presentations.

My desire to serve on this committee is motivated by the insights I gained during the May 2026 Corridor Connect+ LIVE Landowner Workshops and Expo, and the significant volume of development that is occurring in Marion County that appears to have an equally significant negative impact on the county's environmental health and aesthetic quality. My wife and I have resided in 4 states and in 3 counties in Florida. Based on that experience, I believe that Marion County could and should modify their planning strategies and development codes to improve those processes, targeting recognition as a leader in high quality environmental management. My overarching goal is to contribute to solutions for long-term environmental sustainability and to be part of a legacy that we as residents and contributors can be proud of. Much of my life has, and continues to involve outdoor activities including those associated with maintaining and improving our small horse farm here in Ocala, and horseback and bicycle riding on trails within several of the area's recreational sites.

As someone that built a very successful career out of finding innovative solutions to a myriad of challenges, I strongly believe that mutually agreeable strategies and codes should be developed rapidly, but thoughtfully, that protect the environment and wildlife in consideration of human need, and provide economic and aesthetic benefit to developers and the county to the extent practical.
