- 3. <u>Terms.</u> All references in the Agreement to the completion date of August 18, 2025 to November 18, 2025 providing a Ninety (90) Day extension.
- 4. <u>In Full Force.</u> All provisions of the Agreement not specifically amended herein shall remain in full force and effect. Specifically, the funding provided in the Agreement is in no way altered by this Amendment.
