

TASK ORDER TO THE AGREEMENT

In accordance with the Electrical Trades Services Agreement, approved by the Board of County Commissioners on October 5, 2021 (the "Agreement") for work within the scope of Solicitation 21Q-219-TO-10 Belleview Sports Complex New Electric Service and LED Lights, this Task Order to the Agreement (this "Amendment") is made and entered into between Chuck's Stokes Electric of Central Fla Inc. whose principal address 1734 N Magnolia Ave, Ocala, FL 34475, and mailing address PO Box 930, Ocala, FL 34478 and possessing FEIN# 45-4771979 ("CONTRACTOR") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471 ("COUNTY").

WITNESSETH

WHEREAS the parties wish to amend the Agreement as set forth below; and;

IN CONSIDERATION of the mutual covenants and conditions contained herein, the parties do hereby agree as follows:

1. This Amendment shall be deemed to amend and become a part of the Agreement in accordance with the original Solicitation and Agreement for Electrical Trades Services under 21Q-219.

2. CONTRACTOR's services and performance will be in accordance with the scope of service and fee schedule, Exhibit A hereto. The total cost for the Project will not exceed Six Hundred Ninety Thousand Seven Hundred Fifteen Dollars and 00/100 (\$690,715.00). All Work shall proceed in a timely manner without delays. **TIME IS OF THE ESSENCE.** All limitations of time set forth in the Contract Documents are of the essence of this Contractor. The Work may be presumed abandoned after ninety (90) days if CONTRACTOR terminates the Work without just cause or without proper notification to COUNTY, including the reason for termination, or fails to perform Work without just cause for ninety (90) consecutive days.

3. All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
