

**SECOND AMENDMENT TO AGREEMENT BETWEEN
THE SCHOOL BOARD OF MARION COUNTY, FLORIDA
AND WILLIAM “BILLY” WOODS, AS SHERIFF OF MARION COUNTY, FLORIDA
AND BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA
FOR THE SCHOOL RESOURCE OFFICER PROGRAM**

This Second Amendment (“**Second Amendment**”) is made to the School Resource Officer Program Agreement dated the 28TH day of June 2022, as First Amended August 19, 2024 (“**Original Agreement**”), by and between **The School Board of Marion County, Florida**, (“**School Board**”), and **William “Billy” Woods, as Sheriff of Marion County, Florida** (“**SHERIFF**”), and the **Board of County Commissioners of Marion County, Florida** (“**COUNTY**”)

School Board, Sheriff, and County desire to amend the Original Agreement as follows:


1. Under **ARTICLE II, Rights and Duties of the Sheriff** Section B. 2), “Dunnellon High School” is removed and added to Subsection C. 6).
2. Under **ARTICLE IV, Financing the SRO Program** Section 1, the number of SROs will increase from 40 to 41 for the remainder of the Agreement which terminates on June 30, 2025, but will not go into effect until the newly assigned SRO begins their assignment at the school.
3. Under **ARTICLE IV, Financing the SRO Program** Section 2, the monthly rate will increase for the remainder of the Agreement which terminates on June 30, 2025, but will not go into effect until the newly assigned SRO begins their assignment at the school as follows: **$\$75,000/\text{SRO} \times 41 \text{ SROs} = 3,075,000.00$ per year, paid to the County monthly, at a rate not to exceed $\$256,250.00$ per month.**


