

**THIRD AMENDMENT TO INTERLOCAL AGREEMENT
FOR COURT TECHNOLOGY PERSONNEL SERVICES**

This **THIRD AMENDMENT TO INTERLOCAL AGREEMENT FOR COURT TECHNOLOGY COURT PERSONNEL SERVICES** (hereafter "Third Amendment") serves to amend that certain Interlocal Agreement Providing for Court Technology Personnel Services to the Circuit and County Courts in and for Sumter County, Florida, dated September 27, 2016, assigned Marion County Project #16C-200, (hereafter the "Agreement") between **SUMTER COUNTY, FLORIDA**, a political subdivision of the State of Florida, with a principal address of 7375 Powell Road, Wildwood, FL 34785, and **MARION COUNTY, FLORIDA**, a political subdivision of the State of Florida, with a principal address of 601 S.E. 25th St., Ocala, FL 34471 (individually "Party," collectively "Parties").

W I T N E S S E T H:

WHEREAS, the Parties have enjoyed a successful implementation of the Agreement and seek to enter this Third Amendment solely to renew the Agreement pursuant to paragraph "3" therein.

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained in this Amendment, the parties agree to amend the Agreement as follows:

1. **INCORPORATION OF RECITALS AND EXHIBITS.**

The Parties confirm and agree that the above Recitals are true and correct, and incorporate their terms and provisions herein for all purposes.

2. **RENEWAL.**

The Agreement is renewed for an additional two (2) years, valid through September 27, 2027, pursuant to Paragraph "3" of the Agreement.

5. **ALL REMAINING PROVISIONS REMAIN IN FULL FORCE.**

Except as modified by this Third Amendment, all terms and conditions of the Agreement remain in full force and effect for the term of the Agreement.
