## RESOLUTION NO. 25-R-\_\_\_\_

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA, PROVIDING FOR COMMITMENT OF REVENUES: ESTABLISHING REVISED FEES AND RATES FOR SOUTHEASTERN LIVESTOCK PAVILION: PROVIDING FOR REPEAL OF RESOLUTION NO. 24-R-51: PROVIDING FOR DISCOUNTING OF FEES: PROVIDING FOR **DETERMINING** RATES: **PROVIDING** FOR AND Α RESERVATION CANCELLATION POLICY: PROVIDING FOR CO-SPONSORSHIPS: PROVIDING FOR FEE EXEMPTIONS: PROVIDING FOR FEE WAIVERS FOR SPECIFIED NON-PROFIT EVENTS: AUTHORIZING DIRECTOR OF PARKS & RECREATION ESTABLISH A SCHEDULE OF EVENTS: PROVIDING FOR GRANDFATHERED EVENTS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Chapter 14 of the Marion County Code authorizes the Board of County Commissioners to establish fees for the use of the Southeastern Livestock Pavilion; and

WHEREAS, the Board of County Commissioners desires to revise the Fee Schedule for the Southeastern Livestock Pavilion in accordance with "Exhibit A" attached hereto; and

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA, that:

**SECTION 1. Revenues to be deposited in the General Fund**. The revenues generated from fees for the use of the Southeastern Livestock Pavilion shall be deposited in the General Fund.

**SECTION 2. Discounting of Fees.** The Parks & Recreation Director, with approval from the County Administrator, may reduce fees and provide discounts toward the fees for use of the Southeastern Livestock Pavilion for the purpose of marketing and promotion. The reduction of fees for other purposes may be approved by the County Administrator or designee.

**SECTION 3. Determining Rates.** The Parks & Recreation Director, with approval from the County Administrator, is authorized to determine rates for event types that are not specified in "Exhibit A," Fee Schedule, attached hereto.

**SECTION 4. Reservations and Cancellations.** The time period in which to reserve facilities at the Southeastern Livestock Pavilion and to cancel reservations are as follows:

- A. Reservations are taken no more than one (1) year in advance.
- B. Cancellations:
  - 1. Written notice of cancellation at least thirty (30) days prior to the scheduled reservation: full refund of deposit, less administrative fees.
  - 2. Written notice of cancellation less than thirty (30) days prior to the scheduled reservation: forfeit of deposit.

**SECTION 5. Schedule of Fees.** The Board of County Commissioners hereby adopts the attached schedule of fees and charges for the use of the Southeastern Livestock Pavilion, "Exhibit A" hereto. Excluded from such fee schedule are any events at the Southeastern Livestock Pavilion that are co-sponsored with the Board of County Commissioners, the charges for which will be established by individual contracts. All uses of the Southeastern Livestock Pavilion are subject to the execution of an event agreement and performance of all requirements of the event agreement.

**SECTION 6. Additional Costs.** Fees listed in "Exhibit A," Fee Schedule, in this Resolution do not include applicable taxes and administrative fees.

**SECTION 7. Fee Exemptions.** No fees or charges shall be imposed for use of the Southeastern Livestock Pavilion by any of the following entities:

- A. The Board of County Commissioners or any department of the Board of County Commissioners
- B. Any public safety agency or the County or municipal government of Marion County
- C. Future Farmers of America
- D. Southeastern Youth Fair
- E. UF/IFAS Extension, including 4-H
- F. Marion County Master Gardeners

**SECTION 8. Fees for Non-Profit Organizations.** Fees shall be waived for non-profit agencies not listed in Section 7 for meetings, trainings, and fundraising events directly related to the non-profit's mission when held on weekdays however, non-profit agencies shall be responsible for paying a set-up charge. The charge to set up the Auditorium for non-profit events shall be \$300. The charge to set up the arenas for non-profit events shall be fifty percent (50%) of the current rate. Fee waivers will apply to weekday rentals only. Rentals taking place during the weekend (Friday, Saturday, and Sunday) will pay the full rate.

**SECTION 9. Events Excluded from Fee Exemptions.** No fee, charge waivers or exemptions shall be granted for for-profit events, political events, or religious events.

**SECTION 10. Booking of Events.** The Parks & Recreation Director and Southeastern Livestock Manager shall establish the most effective schedule of events based on sound and current event venue operations.

**SECTION 11. Grandfathered Events.** Notwithstanding any rule or policy to the contrary, the Board of County Commissioners does hereby recognize that the following "grandfathered" events may continue to serve alcoholic beverages during the event subject to compliance with Sec. 3-5, Marion County Code of Ordinances, and other appropriate requirements:

- A. Southeastern Pro Rodeo
- B. Shriners Rodeo
- C. Chili Cook Off
- D. Road Builders Feast

**SECTION 12. High Demand Events.** Events designated as a "High Demand Event" in "Exhibit A," Fee Schedule, frequently require a more complex set-up, often need assistance throughout the duration of the event, host over one hundred (100) individuals, and often have significantly more clean-up and/or tear down requirements than other event types. As such, these events also have an increased security deposit.

**SECTION 13. Repeal.** Resolution No. 24-R-51is hereby repealed.

**SECTION 14. Effective Date.** This Resolution shall take effect on the date adopted.
