Subject: Request for Review and Approval – Joint Use of Marion County Debris Site. Please review and approve the attached letter. Per Florida Statutes, Chapter 403, Section 8(a) and (b), a municipality may utilize a jointly designated site with a county when proper authorization is in place. The Marion County debris site (Site ID: 104867) is owned and operated by the County's debris contractor. This contractor, who is also under contract with the City of Belleview, has designated a separate area within the site specifically for storm debris generated by the City of Belleview. Debris from the City is managed independently and is not co-mingled with Marion County's debris. Since the City of Belleview intends to use this existing permitted site, which is already approved for Marion County, the Florida Department of Environmental Protection (DEP) has requested documentation supporting this arrangement.
