

FIRST AMENDMENT TO THE AGREEMENT

In accordance with the Supply of Standard Size Solid Waste Compactors and Containers Agreement entered into on December 21, 2021, and all of its amendments (if any), collectively (the "Agreement") this First Amendment to the Agreement (this "Amendment") is made and entered into by and between **Baler & Compactor Hydraulic Service, LLC**, whose address is 5050 Stepp Ave., Jacksonville, FL 32216; possessing FEIN 47-2390506, (hereinafter referred to as "SUPPLIER") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").

WITNESSETH

WHEREAS this Amendment shall remain in full force and effect until completion of all services required of SUPPLIER, and the parties wish to amend the Agreement.

IN CONSIDERATION of the mutual covenants and conditions contained herein, COUNTY and SUPPLIER (singularly referred to as "Party", collectively "Parties") hereto agree as follows:

- 1. This Amendment shall be deemed to amend and become part of the Agreement in accordance with project 21B-255, (the "Project"). All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
- 2. This Amendment renews the Agreement for One (1) Year, effective January 1, 2024, and ending December 31, 2024 (the "Term").
- 3. The Parties acknowledge the Agreement expired on December 31st, 2023, but in keeping with the practice of the Parties, they have continued under the Agreement and it is their intent with this renewal to formalize that continuation.
- 4. This Amendment adds a rate increase of 3% due to increase in CPI Index as shown in Exhibit A- Schedule of Values
