EXHIBIT A

E-VERIFY, CLARIFICATION

- This Amendment clarifies that all personnel matters, hiring, and firing, etc., for both CONCENTRA and ASSIGNEE, are handled by CONCENTRA's parent company, SELECT MEDICAL CORPORATION, a Delaware corporation, with a principal address of 4714 Gettysburg Road, Mechanicsburg, PA 17055, FEIN 23-2872718 ("SELECT").
- 2. In accordance with Section, 448.095, Florida Statutes, SELECT is duly registered with E-Verify and is the sole employer of individuals who will perform this Agreement on behalf of CONCENTRA and ASSIGNEE, and SELECT does and shall utilize the U.S. Department of Homeland Security's E-Verify system to verify the employment eligibility of all new employees hired by it during the term of this Agreement and shall expressly require any subcontractors performing work or providing services pursuant to this Agreement to likewise utilize the U.S. Department of Homeland Security's E-Verify system to verify the employment eligibility of all new employees hired by the subcontractor during the Agreement term.
- 3. Compliance by CONCENTRA and ASSIGNEE with the terms of this Exhibit, is made an express condition of the Agreement and COUNTY may treat a failure to comply as a material breach of the Agreement.
