SECOND AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN

THE SCHOOL BOARD OF MARION COUNTY, FLORIDA AND

BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA

This Second Amendment to Interlocal Agreement (this "Second Amendment") is made to that certain Interlocal Agreement between The School Board of Marion County, Florida and Board of County Commissioners of Marion County, Florida for the Provision of Advanced Life Support Ambulance Standby Services for High School Football Games dated <u>July 23, 2019</u> (the "Agreement") by and between The School Board of Marion County, Florida, ("SCHOOL BOARD"), and the Board of County Commissioners of Marion County, Florida ("COUNTY").

WITNESSETH

WHEREAS, the Agreement expires by the terms set in the First Amendment on June 30, 2021, and the parties wish to renew the Agreement for a one (1) year period contingent upon the same terms and conditions of the Agreement, as amended, satisfactory performance, and the availability of funds; and

WHEREAS, the Agreement provides for SCHOOL BOARD's hiring COUNTY to provide advanced life support ambulance standby services (COUNTY's "Services") to SCHOOL BOARD's high school football games; and

WHEREAS, SCHOOL BOARD now seeks to hire COUNTY's Services for graduation ceremonies at various locations and dates in the month of June, 2021 ("singularly June 2021 Graduation Ceremony," collectively "June 2021 Graduation Ceremonies"); and

WHEREAS, COUNTY desires to provide its Services for same; and

WHEREAS, the parties wish to extend the Agreement, as amended, for one (1) year and modify the scope of work in the Agreement to add the June 2021 Graduation Ceremonies and 2021 Football Games for COUNTY's Services as set forth on Exhibit "1," attached hereto.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, School Board and County agree as follows:

1. INCORPORATION OF RECITALS AND EXHIBITS.

The parties confirm and agree that the above recitals are true and correct, and incorporate their terms and provisions herein for all purposes

RENEWAL.

The Agreement is hereby renewed to continue for one (1) year, i.e. until June 30, 2022, contingent upon the same terms and conditions of the Agreement, as amended, satisfactory performance, and the availability of funds. One additional one (1) year renewal remains available to the parties going forward.

3. <u>COUNTY'S SCOPE OF WORK, PARAGRAPH "1(A)" OF THE AGREEMENT,</u> AMENDED.

- A. Paragraph "1" of the Agreement entitled "Scope of Work," sets forth COUNTY's work obligations and includes certain football games set forth on Exhibit "A" attached hereto as Exhibit "A".
- B. Paragraph "1(A)(3)" of the Agreement is stricken in its entirety and replaced with the following:
 - 3) maintain records on all services and submit a summary report at the end of the football season or at the conclusion of all June 2021 Graduation Ceremonies, as applicable.
- C. Paragraph "1(A)" of the Agreement is amended to add subparagraph "1(A)(5)" as follows:
 - 5) be in attendance at 2021 June Graduation Ceremonies according to the schedule attached hereto as Exhibit "1."

4. SCHOOL BOARD'S PAYMENT OBLIGATION, PARAGRAPH "1(B)" OF THE AGREEMENT, AMENDED.

- A. Paragraph "1(B)" of the Agreement sets forth SCHOOL BOARD's obligation for payment to COUNTY and is hereby amended to include the June 2021 Graduation Ceremonies.
- B. Paragraph "1(B)(1)" of the Agreement is stricken it in its entirety and replaced with the following:
 - reimburse COUNTY one hundred seventy-five dollars (\$175.00) per hour for each dedicated unit. There will be a two (2) hour minimum fee. If a game or June 2021 Graduation Ceremony is cancelled, SCHOOL BOARD must give COUNTY at least eight (8) hours' notice in order to cancel COUNTY employee overtime. If a game or June 2021 Graduation Ceremony is cancelled

and SCHOOL BOARD does not give COUNTY at least eight (8) hours' notice, SCHOOL BOARD will pay three hundred fifty dollars (\$350.00) to COUNTY. Standby (non-dedicated) units will be provided by COUNTY at no charge. Proper invoices will be submitted to SCHOOL BOARD's Superintendent or her designee, at the end of each month, or at the end of the football season, or at the conclusion of the June 2021 Graduation Ceremonies, as applicable.

5. COMPENSATION, PARAGRAPH "3" OF THE AGREEMENT, AMENDED.

A. The sole modification to paragraph "3" of the Agreement is to strike its last sentence in its entirety and replace it with the following:

"Should the maximum compensation amount above be reached, COUNTY shall not be obligated to provide any further service outlined on Exhibit "A" attached to the Agreement or Exhibit "1" attached to the First Amendment, as applicable, until such time both parties have amended this section of this Agreement."

6. EXCEPT AS MODIFIED, ALL PROVISIONS IN FULL FORCE.

In all other respects, the Agreement between the parties shall remain in full force and effect.
