SEVENTEENTH AMENDMENT TO THE AGREEMENT

In accordance with the Child Abuse Exams Agreement entered into on December 1, 2009, and all of its amendments (if any), collectively (the "Agreement") this Seventeenth Amendment to the Agreement (this "Amendment") is made and entered into by and between **Marion County Children's Advocacy Center, Inc.** (**dba Kimberly's Center for Child Protection**), whose address is 2800 NE 14th St., Ocala, FL 34470; (hereinafter referred to as "Provider") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").

WITNESSETH

WHEREAS this Amendment shall remain in full force and effect until all completion of services required of Provider, and the parties wish to amend the Agreement.

IN CONSIDERATION of the mutual covenants and conditions contained herein, COUNTY and Provider (singularly referred to as "Party", collectively "Parties") hereto agree as follows:

- 1. Allocation of Funds. COUNTY has allocated \$60,000 to provide for Child Abuse Exams as outlined in the Agreement.
- **2. Term.** The term of the Agreement shall be amended and extended for services performed during FY 24/25 defined as October 1, 2024 through September 30, 2025.
- 3. Compensation. Payments shall be made under COUNTY'S established procedure.
- **4. Maintenance of Records.** Provider shall retain copies of all financial records to the Agreement in accordance with the general records schedules established by the Department of State Florida Division of Library and Information Services as calculated from the date funds are dispersed. COUNTY shall have the right to review, inspect, copy and audit all such records during normal business hours and upon reasonable notice.
- 5. Audit. Provider will conduct an annual audit of all its accounts by a Certified Public Accountant.
