CUSTOMER FURTHER AGREES TO PAY ALL REASONABLE COSTS OF COLLECTION OF SAID BALANCE INCURRED BY THE COMPANY, INCLUDING ATTORNEY'S FEES.

CUSTOMER FURTHER AGREES TO INDEMNIFY AND HOLD HARMLESS FROM ANY CLAIMS, ACTIONS, SUITS, AWARDS, DAMAGES, COURT COSTS OR OTHER LIABILITY ASSERTED. FOR PURPOSES OF ANY INDEMNIFICATION PROVISIONS IN THIS AGREEMENT, THE TERM "COMPANY" SHALL INCLUDE ITS RESPECTIVE OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, SURETIES, SUBCONTRACTORS, AND SUPPLIERS.
