02/07/22 10:00 SO - I, Compliance Official S.Owens issued and mailed a Kennel License Letter, Kennel License Application and County Ordinance Book to Pamela Scott. (S.Owens)

03/31/22 14:01 SO - I, Compliance Official S.Owens arrived at location of 6270 SW 157th Ln. I met with Kathleen Brugnoli and Kenneth Weyrauch from Growth Services and the property owner Pamela Scott. Mrs. Scott escorted us onto her property to view her setup. I observed a kennel area on the right property parcel. There was a nursery/grooming building that was climate controlled. The building contained kennel areas for individual dogs or dogs with puppies. There were not currently any litters of puppies on the property. I observed three large kennel areas which contained two dogs that Mrs. Scott advised are normally running loose on the property. There was also a puppy play pen area which housed four young poodles.

On the left property parcel there were individual kennel runs which were under cover. The kennels were approximately 5 ft. wide and 10 ft. long which Mrs. Scott advised were built by the AKC inspection standards. Some of the runs had an individual dog house and some did not. I spoke to Mrs. Scott about ensuring that she provides adequate shelter for each animals housed in an enclosure outside. She advised that she has more dog houses that she can place in the runs. She also discussed wanting to extend the kennels to where the dogs have more room. She discussed this with Growth Services who educated her on what she could do regarding fencing. All dogs observed were in adequate condition. I advised Mrs. Scott that I will either return to verify the shelters have been provided or she can provide proof of such via photographs. I did not find any other violations of Marion County Ordinance. (S.Owens)
