My name is Robert Strickland, and I am writing to respectfully request a reduction or waiver of the civil restitution lien that was filed against me in connection with a 2012 judgment resulting from a 90-day jail sentence for driving with a suspended license.

Since that time, I have made every effort to correct my mistakes and move forward in a positive direction. I paid all fines related to the charge, had my driver's license reinstated in 2017, and have maintained it in good standing ever since—without any further suspensions.

In 2019, I earned my Class A Commercial Driver's License (CDL), and I've been committed to working hard and staying on the right path. Unfortunately, over the years, the amount owed on this lien has increased significantly due to accumulated interest, making it an even greater financial burden than the original debt. This lien has now remained on my record for over a decade.

Having it reduced or waived would be a tremendous blessing to me and my family. It would relieve a burden that continues to follow me from a mistake I've worked hard to make right. I respectfully ask for your compassion and understanding in considering this request.


