
**RECOMMENDATION OF MARION COUNTY CODE ENFORCEMENT BOARD**

## REQUEST TO APPEAR

**Violation:** Marion County Code, Chapter 16, Article III, Section 16-92;  
**Accumulation of junk; unserviceable vehicles**

**Summary:** A Code Enforcement Board lien was recorded on Aug. 24, 2023, for an accumulation of junk on the 0.55 acre parcel on NE 63<sup>rd</sup> St, Ocala. Tenant William Preston has requested to appear on behalf of the owner.

### Department Recommendation

The department's recommendation is that the Code Board recommend to the Board of County Commissioners that they deny the request to reduce / rescind the fine now totaling \$3000 plus costs/fees of \$87.72.

This 0.55 acre improved property is located within an R-1 Residential Zoning Classification.

**BACKGROUND**

On October 31, 2022, Code Officer Sandra Leon mailed Notices of Violation to BACK TO BASIC HOLDINGS LLC and BILL PRESTON for recurring violation(s) on property located at 2331 NE 63RD ST, OCALA.

On January 18, 2023, a Notice to Appear for the March 8, 2023 Code Enforcement Board (CEB) hearing was sent via certified mail to the owners' address of record. Proof of service was by signed green card dated Jan. 23, 2023.

On March 8, 2023, I presented the case regarding an accumulation of junk to the CEB. BACK TO BASIC HOLDINGS LLC representative was not present. The CEB found them to be in violation and directed them to bring the violation(s) into compliance on or before March 30, 2023, or be fined \$50 a day for each day the violation continued past the date set for compliance up to a maximum of \$3,000. A copy of the Board's Order was mailed to the owner via certified mail. Proof of service was by signed green card dated March, 16, 2023.

On April 12, 2023, the CEB imposed the fine per the prior order based on an Affidavit of Continuing Violation filed by Officer Leon. A copy of the final order imposing the fine was mailed to the owner via certified mail. Proof of service was by signed green card dated April 24, 2023. The lien was recorded June 16, 2023.

On December 8, 2023, Officer Leon revisited the property and observed junk still on the property.



**FINAL ADMINISTRATIVE ORDER OF  
THE MARION COUNTY CODE ENFORCEMENT BOARD**


This cause having come before the Code Enforcement Board of Marion County, Florida on **April 12, 2023**, on the petition of Marion County for an Order imposing a fine in Case Number **903312** and the Board having considered the Affidavit of Continuing Violation filed therein, it is hereby found and ordered that:

1. The violation(s) of Marion County Code, Chapter 16, Article III, Section 16-92; Accumulation of junk; unserviceable vehicles, on real property located at **2331 NE 63RD ST, OCALA, Parcel No. 14794-000-00**, Marion County, Florida, was (were) not brought into compliance on or before **March 30, 2023**, as required by the previous Order of this Board dated **March 10, 2023**.
2. In accord with the previous Order of this Board which is incorporated herein by reference, there is hereby imposed upon **BACK TO BASIC HOLDINGS LLC**, a fine in the amount of **fifty dollars (\$50.00) per day, beginning March 31, 2023**, for each day the violation(s) continue(s) past the date set for compliance, which shall continue to accrue daily unless and until the violation(s) is (are) cleared or until extinguished by law. The fine has reached its maximum amount and the amount of the Code Enforcement lien is **three thousand dollars (\$3,000.00)**. The collection agency fee and administrative costs will also be added to the total payoff amount and the lien will be reported to credit bureaus.
3. The violator(s) shall notify the Code Inspector in writing immediately when the violation(s) has (have) been brought into compliance. **IT IS THE RESPONSIBILITY OF THE RESPONDENT(S) TO NOTIFY CODE ENFORCEMENT AT (352) 671-8900, ON OR BEFORE THE COMPLIANCE DATE TO DEMONSTRATE TO MARION COUNTY'S SATISFACTION THAT THE VIOLATION(S) HAVE BEEN CORRECTED.**
4. The violator(s) has (have) the right to file a petition for writ of certiorari to the Circuit Court to appeal the decision of the Board. An appeal must be filed with the Circuit Court within thirty (30) days of the date of this Order. Section 162.11, Florida Statutes, provides as follows:  
*162.11 Appeals - An aggrieved party, including the local governing body, may appeal a final administrative order of an enforcement board to the circuit court. Such an appeal shall not be a hearing de novo, but shall be limited to appellate review of the record created before the Code Enforcement Board. An appeal shall be filed within 30 days of the execution of the order to be appealed.*
5. Failure to comply with this Order within the specific times set forth above will result in the recordation of this Order in the Public Records. This order shall be a lien against any non-homestead real property or personal property now owned by the violator, and any non-homestead real property or personal property which violator may own in the future, until the satisfaction of this order. Such lien may be foreclosed and the property sold to enforce such lien. If such lien is filed, you will be assessed all cost incurred in recording and satisfying this lien.
