FIRST AMENDMENT TO AGREEMENT BETWEEN THE SCHOOL BOARD OF MARION COUNTY, FLORIDA AND WILLIAM "BILLY" WOODS, AS SHERIFF OF MARION COUNTY, FLORIDA AND BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA FOR THE SCHOOL RESOURCE OFFICER PROGRAM

This First Amendment ("First Amendment") is made to the School Resource Officer Program Agreement dated the 28TH day of June 2022, ("Original Agreement") by and between The School Board of Marion County, Florida, ("School Board"), and William "Billy" Woods, as Sheriff of Marion County, Florida ("SHERIFF"), and the Board of County Commissioners of Marion County, Florida ("COUNTY")

School Board, Sheriff and, County desire to amend the Original Agreement as follows:

- Under ARTICLE II, Rights and Duties of the Sheriff Section B. 5), "Horizon Academy at Marion Oaks" is removed and Subsection C. 6) will be added. Subsection C.
 6) will read, "Horizon Academy at Marion Oaks".
- 2 Under **ARTICLE IV**, **Financing the SRO Program** Section 1, the number of SROs will increase from 39 to 40 for the remainder of the Agreement which terminates on June 30, 2025, but will not go into effect until the newly assigned SRO begins their assignment at the school.
- Under ARTICLE IV, Financing the SRO Program Section 2, the monthly rate will increase for the remainder of the Agreement which terminates on June 30, 2025, but will not go into effect until the newly assigned SRO begins their assignment at the school as follows: \$75,000/SRO X 40 SROs = 3,000,000.00 per year, paid to the County monthly, at a rate of \$250,000.00 per month.
- 4 Under ARTICLE II, Rights and Duties of the Sheriff Section 2, Regular Duty Hours of SRO, subsection E. Duties of the SRO paragraph 16), is hereby amended to include the following: "Each SRO shall be a State Certified Law Enforcement Officer and meet any other training certifications required for this position by School Safety Requirements. The "Sheriff" shall require each SRO to maintain the required certifications. The "Sheriff" shall maintain all records of the certifications of the SRO which shall be provided to the "School Board" upon request."
