SECOND AMENDMENT TO THE AGREEMENT

In accordance with the Armed and Unarmed Security Services Agreement entered into on May 17, 2022, and all of its amendments (if any), collectively (the "Agreement") this Second Amendment to the Agreement (this "Amendment") is made and entered into by and between **Giddens Security Corporation**, whose address is 528 S. Edgewood Ave., Jacksonville, FL 32205; possessing FEIN <u>59-2205829</u>, (hereinafter referred to as "FIRM") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").

WITNESSETH

WHEREAS this Amendment shall remain in full force and effect until completion of all services required of FIRM, and the parties wish to amend the Agreement.

IN CONSIDERATION of the mutual covenants and conditions contained herein, COUNTY and FIRM (singularly referred to as "Party", collectively "Parties") hereto agree as follows:

- 1. This Amendment shall be deemed to amend and become part of the Agreement in accordance with the project 22BE-165, (the "Project"). All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
- 2. This Amendment renews the Agreement for an additional two-year term, effective July 1, 2025, through June 30, 2027, in accordance with the terms and conditions of the original Agreement.
- 3. An additional 2.5% pricing increase may be considered on the annual anniversary of the effective date (July 1, 2026), subject to mutual agreement between the parties.
- 4. The parties acknowledge that the Agreement expired on June 30, 2025, but have continued to operate under its terms. It is the intent of the parties, through this Amendment, to formalize the continuation of services without interruption.
- 5. This Amendment revises the pricing schedule for services effective July 1, 2025 through June 30, 2026, as follows:
