#### **RESOLUTION 25-R-**

### A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA, PROVIDING FOR FEES AND COSTS CONCERNING THE REGULATION OF ANIMALS WITHIN MARION COUNTY AND SERVICES AVAILABLE TO THE COMMUNITY; **PROVIDING FOR A SCHEDULE OF FINES AND PENALTIES: PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Marion County Board of County Commissioners (Board) has amended Chapter 4 of the Marion County Code establishing rules and regulations governing animals kept in Marion County; and

WHEREAS, the Board desires to amend the Schedule of Fees and Fines relating to the regulations governing animals kept in Marion County; and

NOW THEREFORE, be it resolved by the Board of County Commissioners of Marion County, Florida:

SECTION 1. FEES AND COSTS. The Board hereby amends the fees and costs to be assessed and collected by Marion County Animal Services attached hereto as Exhibit A.

SECTION 2. FINES AND PENALTIES. The Board hereby amends the fines and penalties attached hereto as Exhibit B to be assessed for violations of Chapter 4 of the Marion County Code. All fines and penalties shall be paid to the Clerk of Court at the Marion County Judicial Center, 110 NW First Avenue, Ocala, Florida 34475. The Schedule of Fines and Penalties attached hereto provides fines for first, second, third, and subsequent violations.

**SECTION 3. CONFLICT.** All Resolutions or parts thereof in conflict with this Resolution are repealed to the extent necessary to give this Resolution full force and effect.

**SECTION 4. EFFECTIVE DATE.** This resolution shall take effect upon adoption by the Board.
