Our Local Housing Assistance Plan (LHAP) strategy will assist with Demolition Replacement for income eligible home owners. Contract to reflect Scope of Work, Loan Terms, and Payment Requirements. Three proposals for the Commissioner's to review:  1. Monthly payment on 50% on loan amount over a 20 year period for plus taxes and insurance - income will not determine payment Example: \$75,000 / 20 years =\$3,750.00 annually; \$3,750 /12 = \$312.50 month (plus 1/12 taxes and 1/12 insurance)  2. Monthly payment on 50% of loan over 20 year period based on 30% annual gross income  Example: \$42,172 (annual income) x 30% = \$12,651.60; \$12,651.60 /12 = \$1,054.30 (plus 1/12 taxes and 1/12 insurance)  3. No mortgage payment on loan over a 20 year period maintaining 20 year deferred mortgage. Monthly Pymt is 1/12 taxes and 1/12 insurance
