## Loproire/Sanctuary to the Maxx Case History

A24-150948 – At large/control – 7/5/24 – Cecily Zuidema reported neighbor's dog continues to run loose, has dug under her fence and chased her chickens, "Scooby Doo" was returned to A/O Dori Lopriore, with a citation for control

A24-150872 – Rabies/license – 7/2/24 – Rabies license check on all animals, after A/O failed to apply for SUP, in total 152 citations were issued for failure to provide rabies vaccine/county license, 28 county licenses were issued between both properties, inspections were conducted on different days due to A/O Dori Lopriore's schedule

A24-149313 - At large/control – 5/7/24 – Cecily Zuidema reported neighbor's dog continues to run at large. Dog identified as JD. No affidavits received, written warning for control issued.

A24-149151 - Aggressive – 4/30/24 – Complainant, Will Williams, was at Ms. Lopriore's residence picking up supplies when he was bitten by the dog identified as Betty Boop, bite did not break skin. Complainant declined to proceed further and no affidavit received. Citation issued for Rabies/License issued.

A24-149139 - Bite- 4/30/24 - Report received from Public safety regarding a worker being bitten by a dog identified as Hamilton. Victim sustained severe injury. Dog in question was euthanized. (It should be noted that the dog involved in this incident is the same dog that was involved in a case listed on attached history, A24-148903)

A24-149030 - Aggressive - 4/26/24 - Cecily Zuidema reported neighbor's dog came into her yard, aggressively chased her husband and his employee, affidavits received, dog in question "Betty Boop" was identified, citation issued for control to animal owner Dori Lopriore

A24-148903 – Bite – 4/22/24 – MCHD reported Rob Garabection was bitten on the left ankle while at a friend's house on 4/19/24, ACO met with Mr. Garabection who advised that he was at Dori Lopriore's Rescue, Sanctuary to the Maxx (Sea Cliff) working on a kennel when a white colored dog pushed open the gate and bit him, another worker Joel was able to get the dog off him and get it back into the kennel, victim sustained two large lacerations which consisted of severe injury, contact was made with Manager Brandy Holmes in person and owner Dori Lopriore via phone, ACO explained requirement for rabies vaccine, county license, quarantine and dangerous dog investigation, affidavits were provided to bite victim and witness to incident, case has been referred to Humane Investigators for a dangerous dog investigation, Ms. Lopriore euthanized the dog in question "Hamilton" after another bite listed above, case was closed

A24-148764 – Cruelty Tether – 4/16/24 – Cecily Zuidema reported animal owner has 2 dogs tethered 24/7, 1 inside metal shed, 1 on carport, no visible water for either dog, ACO responded and met with animal owner Dori Lopriore who advised that she is aware of the tethering ordinance and was outside with the dogs while they were tethered, no dogs were tethered during the ACO's visit, animal owner was educated

A24-148587 – Control – 4/10/24 – Linda Lear reported neighbor's white dog was running loose by her house, ACO met with Mrs. Lear who declined an affidavit in fear of retaliation, she advised that a neighbor Cecily Zuidema also witnessed the dog loose, ACO met with Mrs. Zuidema who was provided an affidavit and advised that she also had photographs that she would submit, ACO met with animal owner Dori Lopriore who advised that the dog walked with her to the mail box, she was educated on proper direct control, no affidavit was received from Mrs. Zuidema

A23-145025 – Cruelty – 12/05/23 – Anonymous caller reported through MCPS, multiple animals living in large amounts of fecal matter, small cages and deceased cats being kept in the freezer, ACO responded and met with Dori Lopriore and observed all animals on the property (Sea Cliff). 30 dogs and multiple cats were observed and in adequate condition, one deceased cat was found in the freezer which Ms. Lopriore was waiting on the cat to be buried, no violations were found

A23-143505 – Bite – 10/16/23 – MCHD reported Aleana Guidenesperon was bitten by cats while working at a rescue (Sea Cliff), ACO contacted the victim who advised that she was moving feral cats from one area to another and had no available PPE to use, she was bit and scratched by multiple cats, she sought medical treatment because her hand got infected, she described three cats she knows to have caused her injuries, ACO met with Dori Lopriore who was not able to confirm which cats were involved as there were multiple cats on the property, rabies documentation was shown to responding ACO, victim did not want to pursue any further, case was closed

A23-141567 – Cruelty – 08/04/23 – Rosina McVicker called requesting a well-being check on 170 cats and 30 dogs, animals were found in adequate condition, another case A23-138823 was already open to follow up regarding proper shelter

A23-139850 – Cruelty – 06/07/23 – Donna Wilson reported the dog "Nat Nat" as having a large hole in the leg, 100 cats in the house with an outbreak of illness, ACO met with Dori Lopriore who allowed her to see "Nat Nat" who was a recent surrender from Citrus County with multiple broken bones, the dog was in adequate condition and moving without issue, another case A23-138823 was already open to follow up regarding proper shelter

A23-138823 – Control – 05/03/23 – Brenda Ackert reported neighbors' dogs and cats are running loose, other dogs tethered at a rescue, animals were found in adequate condition, the loose dog in question did not belong to Ms. Lopriore and she also provided photographs when she has attempted to trap it, she also discussed that there are community cats in the area, she was educated on TNR/SNR of the cats, multiple dogs were found to be enclosed without adequate shelter, she was educated, rechecks were conducted until Ms. Lopriore provided adequate shelter for all dogs

A23-135990 - Cruelty - 1/27/23 - Maranda Edge reported 1 blue/white pit type dog tethered to a tree without shelter, ACO met with Ms. Lopriore who advised that the dogs are tethered when they are cleaning the kennels, she was educated on tethering, no violations were found

A22-134715 – Cruelty – 12/16/22 – Anonymous well-being check on over 100 cats and 20 dogs, ACO met with Ms. Lopriore and observed 6 dogs and approximately 220 cats on the property, the cats were housed in multiple different sheds on the property, all animals were found in adequate condition, enclosures were found to be clean and free of feces/urine

A20-110487 – Cruelty -8/14/20 – Anonymous complaint on rescue keeping 100 cats in sheds and house, several dogs in cages, ACO met with Ms. Lopriore who had approximately 125 cats housed in three sheds all of which were found in adequate condition with access to food and water, three dogs were observed on the property without proper shelter, animal owner was educated on proper shelter which she provided before the case was closed, RV was submitted to MCAS, owner advised she recently bought the property and moved from South Florida, she had not established a 501c3 but has the intention to, 501c3 status was verified prior to case being closed
