Minutes September 09, 2024

The meeting of the Marion County Historical Commission was called to order by President Dr. Richard Cardinali at 6:00 p.m. on Monday, Sept 09, 2024 at the Marion County Growth Services Building, 2710 E. Silver Springs Blvd, Ocala, FL 34471.

The Pledge of Allegiance was led by Dr. Cardinali.

PUBLIC COMMENT: Mr. Brooks, member of Sons of the American Revolution addressed the commission on the importance of Florida to America's cause in the American Revolutionary War, and the entire Southern Theater in general. He discussed Francis Marion, the Battle of Yorktown, and desire to recognize the 10/19 surrender by the British at Yorktown. His desire is to enlist the BOCC to promote such recognition.
