Sherri Meadows made a motion to approve a TEFRA Hearing for Gridiron, LLC, and the motion was seconded by Rebecca Gavidia and the motion passed to move forward with rescheduling the TERFA Hearing.

VIII. Open Discussion

The HFA also agreed to have First Housing Underwriting to conduct an early review of the proposed Gridiron Development and any future developments seeking Bond Financing. First Housing will provide a written review report of their findings.

There was also a discussion about the staff working up the cost to repair the damaged home and then working with the County to sell the mobile home, located at 1370 NW 112th Ave Ocala.
