

FIRST AMENDMENT TO THE AGREEMENT

This First Amendment to the Agreement made and entered into May 5, 2009, by and between **Guerra Development** (Engineer), whose address is 2817 NE 3rd St, Ocala, FL 34470; Possessing Federal Employee Identification Number (FEIN) **59-2615012**, and Marion County Board of County Commissioners (Owner), 601 SE 25th Avenue, Ocala, Florida, 34471.

WITNESSETH

WHEREAS, the parties entered into an agreement dated April 17, 2007, this agreement shall remain in full force and effect until all completion of services required of the Engineer, and the parties wish to amend such agreement.

IN CONSIDERATION of the mutual covenants and conditions contained herein, the parties do hereby agree as follows:

1. This Agreement shall be deemed to amend the original contract between, Marion County Board of County Commissioners and Guerra Development for **reduction in labor rates**, in accordance with the Request for Qualifications #06Q-098.
2. The new labor rates will remain in effect, as listed below, until the economy improves and the Board of County Commissioners approve for rates to be re-negotiated:

3. All provisions of the original contract document not specifically amended herein shall remain in full force and effect.




