## THIRD AMENDMENT TO THE AGREEMENT

WHEREAS this Amendment shall remain in full force and effect until completion of all services required of SUPPLIER, and the parties wish to amend the Agreement.

- 2. This Amendment renews the Agreement for Five (5) years with a five-year renewal option available upon mutual agreement, effective November 1, 2025 and ending October 31, 2030 (the "Term").
