WITNESSETH


WHEREAS this Amendment shall remain in full force and effect until completion of all services required of CONTRACTOR, and the parties wish to amend the Agreement.

1. This Amendment shall be deemed to amend and become part of the Agreement in accordance with the project 17P-103, (the "Project"). All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
2. This Amendment renews the Agreement for One (1) year term, effective October 1, 2024 and ending September 30, 2025 (the "Term"). Pending mutual request, and Board approval, there are seven (7) one (1) year term renewal options available. All Work shall proceed in a timely manner without delays.

IN WITNESS WHEREOF the Parties have entered into this Amendment, as approved by the Marion County Board of County Commissioners, on the date of the last signature below.




