Delee Perry will be loaning her memorabilia to the display, and Mr. Richards donated copies of the digital files to them also. Their museum is anticipated to open in 3+ months. Mr. Richards has given his invoice to Procurement, and copy to Becky ?Jane?.

Regarding the Roosevelt Village/Camp Roosevelt marker, Mrs. Long reports talking to Jennifer Clark, and they're still awaiting approval by Florida Department of Environmental Protection.
