

# AMENDMENT NO. 1 TO AGREEMENT BETWEEN MARION COUNTY AND KIMLEY-HORN AND ASSOCIATES, INC. DATED, SEPTEMBER 9, 2024 PROJECT #24Q-226

## CROSS FLORIDA GREENWAY BASELINE RD. TO SANTOS PAVED TRAIL

#### PROJECT UNDERSTANDING

Marion County (the "COUNTY" or the "Client") has requested an Amendment to the Agreement with Kimley-Horn and Associates, Inc. ("Kimley-Horn" or the "ENGINEER") for the Cross Florida Greenway Project.

#### INTRODUCTION

Kimley-Horn is currently providing design and permitting services for the Project. Under this Amendment, the County has requested Kimley-Horn to provide a Cultural Resource Assessment Survey. Under this Amendment, Kimley-Horn will provide services as noted herein.

#### SCOPE OF SERVICES

## TASK 1 – CULTURAL RESOURCE ASSESSMENT SURVEY (CRAS)

- A. The CRAS will be performed along the proposed trail alignment within parcel numbers 36653-000-00 and 36637-000-00. Prior to the field survey, Kimley-Horn will conduct background research utilizing the Florida Master Site File (FMSF) and other historical data to determine those previously recorded cultural resources and surveys within the project Area of Potential Effects (APE) and a 0.5-mile buffer. This research, in conjunction with environmental data, will inform our expectations of identifying potentially unrecorded archaeological sites or historic resources with the APE.
- B. The Phase 1 CRAS will be undertaken per the Division of Historical Resources (DHR) Module 3, Guidelines for Use by Historical Preservation Professionals (2003) and intends to identify potentially unrecorded cultural resources within the archaeological and historic resources project APE and assess the significance of these resources regarding their eligibility for listing in the National Register of Historic Places (NRHP). This Phase I survey will be conducted to Federal and State standards.

## C. Deliverables

1) Phase I CRAS report will be prepared per State and Federal standards. The report will document and assess the effects of the proposed project on cultural resources within the APE for that specific area, if present, and provide recommendations as to their potential eligibility for listing on the NRHP.

## **SCHEDULE**

Kimley-Horn will provide the above Scope of Services in an expeditious and orderly manner to meet a mutually agreeable schedule.

## FEE

The ENGINEER will provide the services described in the Scope of Services for a lump sum amount of \$15,730.00 as detailed in the attached TABLE A.
