

FIRST AMENDMENT TO THE AGREEMENT

In accordance with the Cleaning Products, Dispensers & Paper, Soap Products Agreement entered into on October 17, 2023, and all of its amendments (if any), collectively (the "Agreement") this First Amendment to the Agreement (this "Amendment") is made and entered into by and between **GEM Supply Company**, whose address is 1312 W. Washington Street, Orlando, FL 32805; possessing FEIN **59-1633718**, (hereinafter referred to as "SUPPLIER") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").

WITNESSETH

WHEREAS this First Amendment shall remain in full force and effect until completion of all services required of SUPPLIER, and the parties wish to amend the Agreement.

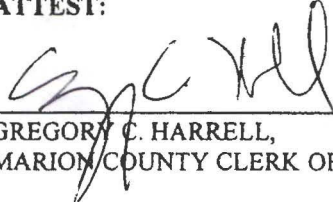

1. This Amendment shall be deemed to amend and become part of the Agreement in accordance with the project identified as 24BE-032, (the "Project"). Attached Exhibit A – Price List replaces the previous Exhibit A. All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
2. This Amendment renews the Agreement for One (1) Year, effective January 1, 2025 and ending December 31, 2025 (the "Term").

FIRM agrees to accept all notices solely by e-mail and designates e-mail addresses: bzagers@gemsupply.net and dcunningham@gemsupply.net. Designation signifies FIRM's election to accept notices solely by e-mail.
4. All provisions of the Agreement not specifically amended herein shall remain in full force and effect.

IN WITNESS WHEREOF the Parties have entered into this Amendment, as approved by the Marion County Board of County Commissioners, on the date of the last signature below.

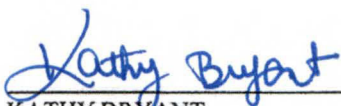
