RECREATION SPECIALIST – Kari Coates

School Supply Drive: For our School Supply Drive, we had 3,786 individual items, in addition to more that came in after we had turned in the supplies. All of the supplies have gone over to teachers and students at Marion Oaks Elementary, Sunrise Elementary, and Horizon Middle School.

Back to School Expo: Was very successful. We had 94 families that attended, 205 kids that came through and the vendors were very excited about having participated. During the event we had 12 families sign up to be foster families, we had 11 families with children with disabilities sign up for assistance. The Blood mobile had nine donors, the Library had one new member sign up and 5 renewals, and the Health Department Bus was there administering vaccines. They were busy all day and couldn't provide the exact numbers. Girl Scouts reported they had the largest turnout ever for registration. The event as a whole was very successful.

Glow Party: During this event, staff member Victor Adams was the DJ and Nikko Montanez was there helping set up and taking video. 47 children and their families were registered.

Upcoming Programs:

We are possibly going to do an open mike-night and community dinner with the date yet to be determined.

We have been able to get most of the staff here in Marion Oaks certified in adult and pediatric CPR and AED training and we plan to have a free educational CPR Class to the community to receive the training without the certification.

FACILTIES TRADES SUPERVISOR – Charles Aman

AC for Sheriff's Office: The AC went down about four months ago. We got a new unit, and it is up and running.

Splash Pad: Needed two new valves. They were installed by Aquaworks two or three months ago, and are working well.

Metal Doors: We will be putting new metal doors on Building A and the cost for that will be \$14,000 to \$15,000. Also, they will be replacing the one door by the pickleball courts.

Grounds Maintenance: The crew has been busy mowing and weeding the grounds at the new dog park, which has been taking up a lot of their time now.

Pressure Washing: We have already start pressure washing all the buildings and the walkways. **Basketball Courts:** Goals and courts will be stripped down and repainted, the backboards and the hoops will be painted.

Storm Maintenance: A storm did come through on Monday and two trees fell, but did no major damage.

COMMUNITY CENTER MANAGER – David Pierce

Carole LaMotte, our advisory board member has decided to resign effective July 16th. Carole has been very involved in many projects here and has been very instrumental in helping getting things done. As with all Board members she has one focus and that one focus is making Marion Oaks a better place to live. On a personal note, Dave stated that Carole is one of the nicest people he's ever met and

BUDGET PRESENTATION TO BOARD OF COUNTY COMMISSIONERS

On July 9th we presented our budget to the County Commissioners. There were no flags that came up in our budget, and Dave has included a proposed budget in every board member's folder. Major projects next year include the repaving of the walking trail, and an outdoor fitness obstacle course. Also, possibly a court yard at the annex building to expand and give us table seating for outside. Some of our major purchases include buying a new tractor, and new exercise equipment. If there's anything on that proposed budget that the Board has any questions they are welcome to see Dave any time. As of right now the County Commissioners have no issues on what we decided to go forward with at our prebudget workshop.

Building A, B Roofs: We had an engineer out here Friday and it was determined that these roofs need to be replaced. It is a very extensive project and it will need to go out to bid. It will be very labor-intensive since all the tile roofs will be replaced with either an architectural shingle or a metal shingle depending on the cost. We ask that everyone be patient and if the Board could spread the word that we are going to be experiencing some interruptions down the road once the work is started. Board member Alice Mitchell asked if there was an estimate yet for the cost, to which David Pierce responded that we did not have that at this time. As soon as it goes out to bid and he gets the bids back and it has been approved by the County Commissioners he will email the board, if we are in between meetings. He let the board know that it would not be cheap.

Current Projects: Dog Park

We are having the grand opening of the Dog Park today. It has been a long time coming. Residents have already been going to the Park, and they are very excited. Dave wanted to thank the Board for their support on this project.

Pickleball Court Expansion

Our Pickleball expansion that was discussed at the last meeting ran into an issue, where the engineer determined that a site plan was needed to make sure that we had proper drainage, etc. That actually had to go out for a re-bid and it is slated to be on the Board of County Commissioners Agenda on August 20th. Once that gets approved, Dave expects that the expansion will start shortly after since according to Project Coordinator, Pete Hodges – once a contractor is notified that they have the contract, they have 30 days to finish the concrete work.

Tropical Storm Debbie: Everybody here is well aware of Tropical Storm Debbie. We are designated as a sand distribution center. The people in Marion Oaks have become very dependent on that fact. This is the third year in a row that we have been a designated sand distribution site, and the third year in a row that we have been the most productive as far as giving out the most sand. We distributed over 7,000 bags this past storm. And a thank you to Chad Wicker, MSTU Director for making that arrangement because the people here really depend on that.

Incidents: No major incidents.

Staffing: We have one staffing issue. As you are aware David Menzie retired a couple of months ago. There were some interviews that were conducted last Wednesday and we are just waiting on the HR Department.

Shortly after this meeting we will be heading over to the Dog Park for the Ribbon Cutting Ceremony. **Donation to the Dog Park:** David Pierce wanted the Board to know that the Civic Association graciously donated \$200 towards the Dog Park. The Civic Association does so much for the community, and work just as hard as our Board members to try to keep standards high in Marion Oaks. We truly appreciate their donation towards the Dog Park. Applause ensued.
