

SIXTH AMENDMENT TO THE AGREEMENT

In accordance with the Limerock Supplier Agreement entered into on January 19, 2021, and all of its amendments (if any), collectively (the "Agreement") this Sixth Amendment to the Agreement (this "Amendment") is made and entered into by and between **Boxley Materials Company d/b/a Quikrete Aggregates**, whose address is 5 Concourse Parkway, Suite 1900, Atlanta, GA 30328; possessing FEIN **54-0144200**, (hereinafter referred to as "SUPPLIER") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").

The Parties hereby acknowledge the SUPPLIER's change in principals and the change in name from Florida Stone Products, LLC d/b/a Georgia Stone Products – Ocala Quarry (FEIN 98-0632107) to Boxley Materials Company d/b/a Quikrete Aggregates (FEIN 54-0144200). 3. Pursuant to Exhibit A benefits and obligations under the agreement are hereby assumed by Boxley Materials Company d/b/a Quikrete Aggregates.
