CALL TO ORDER

Chairman David Tillman Called the Meeting to Order at 5:33 p.m.

ROLL CALL & PLEDGE OF ALLEGIANCE

Rebecca Brinkley called roll, and the quorum was confirmed.

Board members present were Chairman David Tillman, Richard Busche, Gene Losito, and Erica Larson.

Staff members present were Chief Assistant County Attorney Dana Olesky, Assistant County Administrator Tracy Straub, Growth Services Director Chuck Varadin, Growth Services Deputy Director Ken Weyrauch, Development Review Coordinator Elizabeth Madeloni, Planner Kathleen Brugnoli, Planner Erik Kramer, and Staff Assistant Rebecca Brinkley.

1. ADOPT THE FOLLOWING MINUTES

2.1 Discussion for Proposed Marion County Land Development Code (LDC) Amendments to Review and Update Article 1, Division 2, Definitions

2.2 Discussion for Proposed Marion County Land Development Code (LDC) Amendments to Review and Update Article 6, Division 7 Tree Protection and Replacement

Due to time constraints, this item was not addressed and is postponed to a future meeting.

2.3 Discussion for Proposed Marion County Land Development Code (LDC) Amendments to Review and Update Section 4.2.2 General Requirements for all Agricultural Classifications

Ken Weyrauch, Growth Services Deputy Director, opened the discussion regarding this item.

LDRC Board Members voiced their recommendations and comments regarding the current language.

Ken Weyrauch provided a copy of language pertaining to solar facilities drafted by LDRC Board Member Richard Busche.

There was no public comment provided.

These updates will finalize the board's recommendations, and this item will be moved to a public hearing on December 2, 2025. LDRC Board Member Gene Lositio made a motion to adopt the changes and to proceed to a public hearing. Motion was seconded by Board Member Erica Larson. Motion passed unanimously (4-0).

2.4 Discussion for Proposed Marion County Land Development Code (LDC) Amendments to Review and Update Article 1, Division 2 Definitions

Chairman David Tillman opened the discussion regarding this item.

LDRC Board Members voiced their recommendations and comments regarding the current language.

The following members of the public spoke during Public Comment:

- 1. Dirk Leeward PO Box 1476, Ocala
 - Presented the letter he submitted to the LDRC Board outlining recommended revisions to language proposed by Sterns, Weaver, and Miller at the November 5, 2025, meeting.
- 2. Barb Stanley 99 NW 117th Street, Ocala
 - Expressed desire for language to address aircraft once they are in the air.
- 3. Tim Gant 17820 SW 3rd Street, Micanopy

- Asked why ten residential units were chosen in the definition for a Fly-In Community as opposed to a smaller number. States he feels any amount over four would constitute a community.
- 4. Jenny Susser 12191 N Magnolia Avenue, Ocala
 - Opposed, the proposed language is very liberal. States she spoke against
 Jumbolair previously and feels she was "buzzed" by low-flying aircraft as a
 result and expressed concern that this will happen again as a result of
 speaking out at this meeting. Feels a Fly-In Community's use should be for
 transportation purposes and not for military planes that are dangerous, noisy,
 and perform in air acrobatics. States that the aircraft have a negative impact on
 adjacent properties and should not be allowed to fly over agricultural land due
 to the accidents that result from horses.
- 5. Jenny Vallner 11455 N Magnolia Avenue, Ocala
 - Opposed, asked if the air traffic of a Fly-In Community has been compared to
 the air traffic generated by Ocala International Airport. Pointed out that there is
 no limit on the number of trips into and out of a Fly-In Community, and feels a
 Fly-In Community has the potential to generate more traffic than Ocala
 International Airport. Expressed safety concerns and mentioned that there
 would be no control tower to monitor and direct the air traffic for the
 community. States the language needs to address air traffic and the number
 of aircraft permitted in the community, as well as how many residences will be
 approved for the community.

Public comment was closed by the Chair.

Ken Weyrauch noted items that need to be followed up on. The Board agreed that more discussion on the language was needed. Mr. Weyrauch will make edits to the verbiage and bring the item back to a future workshop.

2.5 Discussion for Proposed Marion County Land Development Code (LDC) Amendments to Review and Update Article 4 to Add New Section 4.3.28 – Fly-In Communities, and Add New Section 4.3.29 – Private Airports

Chairman David Tillman opened the discussion regarding this item.

LDRC Board Members voiced their recommendations and comments regarding the current language.

Chair David Tillman stated for the record that the board would presume that the public comment previously stated in companion item 2.4 would also be applied to the present item and shall be incorporated by the previous reference.

Public comment was closed by the Chair.

Ken Weyrauch noted items that need to be followed up on. The Board agreed that more discussion on the language was needed. Mr. Weyrauch will make edits to the verbiage and bring the item back to a future workshop.
