

FIFTH AMENDMENT TO THE AGREEMENT

In accordance with the Limerock Supplier Agreement entered into on February 2, 2021, and all of its amendments (if any), collectively (the "Agreement") this Fifth Amendment to the Agreement (this "Amendment") is made and entered into by and between **M. J. Stavola Farms, Inc., dba M.J. Stavola Industries**, whose address is 2600 NW 77th Street, Ocala, FL 32617; possessing FEIN **59-1292774**, (hereinafter referred to as "SUPPLIER") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").

WITNESSETH

WHEREAS this Amendment shall remain in full force and effect until completion of all services required of SUPPLIER, and the parties wish to amend the Agreement.

IN CONSIDERATION of the mutual covenants and conditions contained herein, COUNTY and SUPPLIER (singularly referred to as "Party", collectively "Parties") hereto agree as follows:

1. The parties acknowledge that the Agreement expired, but in keeping with the practice of the Parties, they have continued under the Agreement, and it is their intent with this renewal to formalize that continuation.
2. This Amendment shall be deemed to amend and become part of the Agreement in accordance with the project 21Q-042, (the "Project"). All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
3. This Amendment is effective Upon Board Approval through January 31, 2027 (the "Term").
4. This Amendment replaces Exhibit B, Pricing Sheet, of the Third Amendment between Parties in order to provide new pricing to the Agreement per ton value with the following pricing below:

Material Type	Cost Per Ton
Material for Limerock Base	\$9.50
Material for Limerock Stabilized Base	\$13.00
