Dear Commissioners:

Tonight's public hearing is the first of two public hearings required to be held pursuant to the provisions of Section 200.065(2), Florida Statutes, prior to the adoption of a budget and millage rate for the Rainbow Lakes Estates Municipal Service District. As such, this is not a final budget hearing, and final adoption of the fiscal year 2025-26 millage rate and budget will not be considered at this hearing.

The Rainbow Lakes Estates Municipal Service District fiscal year 2025-26 tentative budget totaling \$1,613,373 is scheduled for consideration by the Marion County Board of County Commissioners, duly constituted as the District Board of the Rainbow Lakes Estates Municipal Service District, at tonight's budget hearing.

The procedures to be followed at this public hearing, as set forth in Section 200.065, Florida Statutes, are as follows:

- (1) Announce the percentage increase in the proposed millage rate over the rolled back rate.
- (2) Discuss the specific purpose(s) for the tax increase, if applicable.
- (3) Allow comments from the public regarding the adoption of the tentative budget.
- (4) Publicly announce the name of the taxing authority, the rolled-back rate, the percentage increase, and the millage rate to be levied.
- (5) Adopt the tentative millage rate by resolution as revised.
- (6) Adopt the tentative budget by resolution as amended.
- (7) Publicly announce the percentage increase, if any, of the tentative millage rate over the rolled back rate.

Following completion of these procedures, the Board must establish and announce the date, time, and place of the public hearing to consider final adoption of the millage rate and budget as amended. This must be an advertised hearing, held after 5:00 p.m., that must be advertised within 15 days of the conclusion of tonight's public hearing.

A summary of the tentative fiscal year 2025-26 budget for the Rainbow Lakes Estates Municipal Service District is attached for your information.
