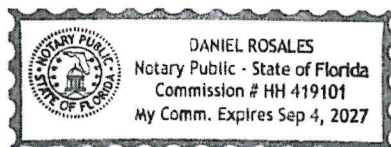

Gary Yard supervised and performed structural and selective demolition of commercial, residential, and industrial buildings. He operated heavy equipment (excavators, loaders, skid steers, hydraulic hammers) for building and foundation removal. Directed crews in safe removal of walls, slabs, footings, roofing, and structural steel. Coordinated utility disconnections, environmental checks (asbestos/lead), and site safety plans. Gary also loaded, hauled, and disposed of debris per local and state requirements. He performed saw cutting, core drilling, and interior soft demolition. Lastly he managed site cleanup, grading, and preparation for new construction.

Gary worked on a variety of projects such as: residential house demolitions (single-family homes, duplexes), commercial building demolitions (retail spaces, office buildings, warehouses), industrial structures (concrete pads, tanks, and small manufacturing facilities). He also performed selective interior demolition (tenant build-outs, office remodels, hotel renovations), site demolition including driveways, sidewalks, curbs, parking lots, and underground utility structures, bridge and retaining wall removals, and pool and slab removals.

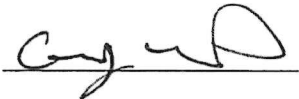
Statement Regarding Past Legal History

In October 2000, I was arrested and later entered a plea agreement for a felony charge of false imprisonment related to a physical altercation involving an individual who had an issue with someone in the group I was with. No one was seriously injured, but due to my lack of legal knowledge at the time, I accepted a plea to resolve the case. I successfully completed all probation terms and paid all associated fines.

In March 2015, I entered a no contest plea to a misdemeanor assault charge in Hawaii following an incident in which I was attacked by multiple individuals and acted in self-defense. The court process was repeatedly delayed, and I was forced to travel back and forth from the mainland. To avoid continued financial strain and disruption, I agreed to a plea deal. I again completed probation and fulfilled all obligations to the court.

Since that time, I have remained fully compliant with the law, built a career in the construction industry, and dedicated myself to my family. I am now married with three children, and in 2023 we purchased a home in Ocala, Florida. Both my wife and I are active professionals in the construction field, and I continue to work hard, grow my businesses, and contribute positively to my community.
