

FIRST AMENDMENT TO THE AGREEMENT

In accordance with the Countywide PPE Agreement entered into on September 14, 2021, and all of its amendments (if any), collectively (the "Agreement") this First Amendment to the Agreement (this "Amendment") is made and entered into by and between Safety Products, Inc., whose address is 3517 Craftsman Blvd., Lakeland, FL 33803, with a mailing address of PO Box 1688, Eaton Park, FL 33840; possessing FEIN 59-2282857, (hereinafter referred to as "SUPPLIER") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").


WITNESSETH


WHEREAS this Amendment shall remain in full force and effect until completion of all services required of SUPPLIER, and the parties wish to amend the Agreement.

IN CONSIDERATION of the mutual covenants and conditions contained herein, COUNTY and SUPPLIER (singularly referred to as "Party", collectively "Parties") hereto agree as follows:


- 1. This Amendment shall be deemed to amend and become part of the Agreement in accordance with the project 21P-102, (the "Project"). All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
- 2. This Amendment renews the Agreement for One (1) Year, effective Upon Board Approval and ending September 30, 2024 (the "Term").
- 3. The Parties acknowledge the Agreement expired September 30, 2023, but in keeping with the practice of the Parties, they have continued under the Agreement and it is their intent with this renewal to formalize that continuation.
- 4. This Amendment revises the Fee Schedule - Exhibit B of the Agreement to reflect an increase or decrease in the original price for only the items shown on Attachment 1 - Fee Schedule Cost Changes.

IN WITNESS WHEREOF the Parties have entered into this Amendment, as approved by the Marion County Board of County Commissioners, on the date of the last signature below.




