As we discussed and have indicated all along, Fluidyne never received a purchase order for a 316 stainless steel grit vortex chamber or grit dewatering classifier. Our po was for the 304 stainless steel option. That is what was purchased even though a 316 SS option was quoted. We submitted on 304 stainless steel grit removal equipment and that is what was approved and that is what we manufactured.

As it stands and even though the problem with the existing equipment has to do with high H2S and not to inferior or defective equipment, we have provided a resolution out of good will. Below is the agreed upon option that will bring final closure to this issue:

Provide special pricing for purchase of a completely new grit vortex chamber fabricated out of fiberglass reinforced polyester that would be fabricated to the same materials as the original unit that we supplied as well as a new 316 SS grit dewatering classifier.

### **PRICING**

Price includes FOB factory of all supplied equipment contained in the above scope of supply, with freight allowed to jobsite, Silver Springs Shores WWTP, 420 Emerald Rd, Ocala, FL 34472. All un-loading, jobsite storage and installation is the responsibility of others.

**Price for Above.....US\$ 140,000.00**

Price is exclusive of taxes. If taxable, applicable taxes will need to be added to the price.

This agreement includes the equipment, items contained in the above scope of supply. This agreement does not include:

- Removal and demolition of the existing equipment
- Electrical and mechanical installation of the new equipment
- Blowers or blower equipment of any kind
- Screening equipment
- H2S mitigation system
- Any interconnecting/supply piping, valves or supports
- Remote panels, junction boxes or disconnects
- Electrical conduit and wiring
- Walkways, hand railing or platforms
- Hoist or lifting equipment
- Design, supply or installation of anchor bolts
- Motor starters, VFD's or related controls (except starters as noted above)
- Control of any equipment not related to items in the Fluidyne scope of supply
- Sales, PST, GST, use taxes, duties, customs fees or taxes of any kind
- Permits or regulatory requirements of any kind
- Unloading or installation of items delivered to the jobsite
- Field welding or painting of any kind, if required
- Field service
- Any item not specifically mentioned above

## **SCHEDULE**
