

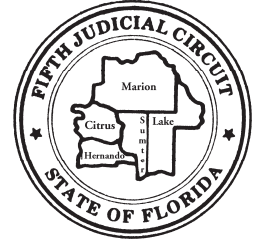

DESCRIPTION/BACKGROUND: On July 2, 2024, Chairman Michelle Stone designated Regina Lewis to serve as the lead applicant for the BJA FY24 Comprehensive Opioid, Stimulant, and Substance Use Site-Based Program for the project titled Marion County (Florida) Family Treatment Court. On November 16, 2024, we received notification from the Department of Justice that we have been selected for an award of \$1,300,000.
