[Historical note – The jug was found in Marion County by James Vernon Priest (1907-1982). His horse kicked it up while he was riding around a low pond on a turpentine job. Priest was a lifelong resident of Ft. McCoy.]

d. Tydings & Co. drug store label for "Black R" patent medicine




e. Tydings & Co. drug store flyer with order form on reverse





[Historical note – Charles Richard Tydings (1864-1939) and his son Charles Robert Tydings (1893-1970) owned Tydings & Co. drug store. The business was founded in the 1890s and was located on the west side of what is now SE 1<sup>st</sup> Ave. between Broadway & Ft. King. The younger Tydings served in the First World War.]
