Also, this month's revolving display at the museum is on Marti City, and was put together by Dr. Cardinali.

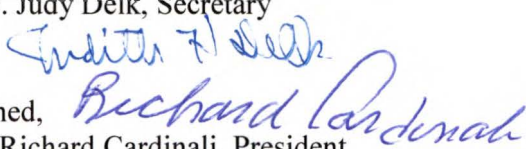
Discussion of the logo for the Marion County Historical Commission: Woods Printing cannot find the record of having that design. Jennifer Clark has been unable to locate the
