

RESOLUTION NO. 07-R-263

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA, APPROVING THE ISSUANCE OF A SPECIAL USE PERMIT, PROVIDING AN EFFECTIVE DATE.

WHEREAS, an application for a Special Use Permit was duly filed by Pigeon-Roberts & Associates, LLC, and was considered by the Marion County Zoning Commission at its meeting on May 30, 2007; and

WHEREAS, the aforementioned application was considered at a public hearing held by the Board of County Commissioners of Marion County, Florida at its meeting on Tuesday, June 19, 2007; now therefore,

BE IT RESOLVED by the Board of County Commissioners of Marion County, Florida:

SECTION 1. SPECIAL USE PERMIT APPLICATION APPROVAL 070606SU – Vikings, LLC. The application for a Special Use Permit as submitted by Pigeon-Roberts & Associates, LLC, a copy of said application being on file with the Zoning Director, is hereby approved for a special use permit in a PUD (Planned Unit Development) zoning classification on 1.96 acres for the intended use of a model home as a temporary golf clubhouse on Parcel Account Nos. 34546-122-00, -123-00, 124-00, -125-00, -126-00, -127.00, and a portion of 34546-000-13.

SECTION 2. FINDINGS AND CONDITIONS. The Board of County Commissioners agrees with the recommendation and findings of the Zoning Commission recommending approval of the Special Use Permit and the Board approves the Special Use Permit subject to the following conditions:

1. The site shall be developed and operated consistent with the submitted conceptual plan and the conditions as provided with this approval.
2. This Special Use Permit shall expire June 30, 2010.

SECTION 3. REVOCATION. Violation or failure to comply with one or more condition(s) of this Special Use Permit could result in revocation of this Special Use Permit by the Board at a noticed public hearing.

SECTION 4. EFFECTIVE DATE. This Resolution shall take effect immediately upon its adoption.

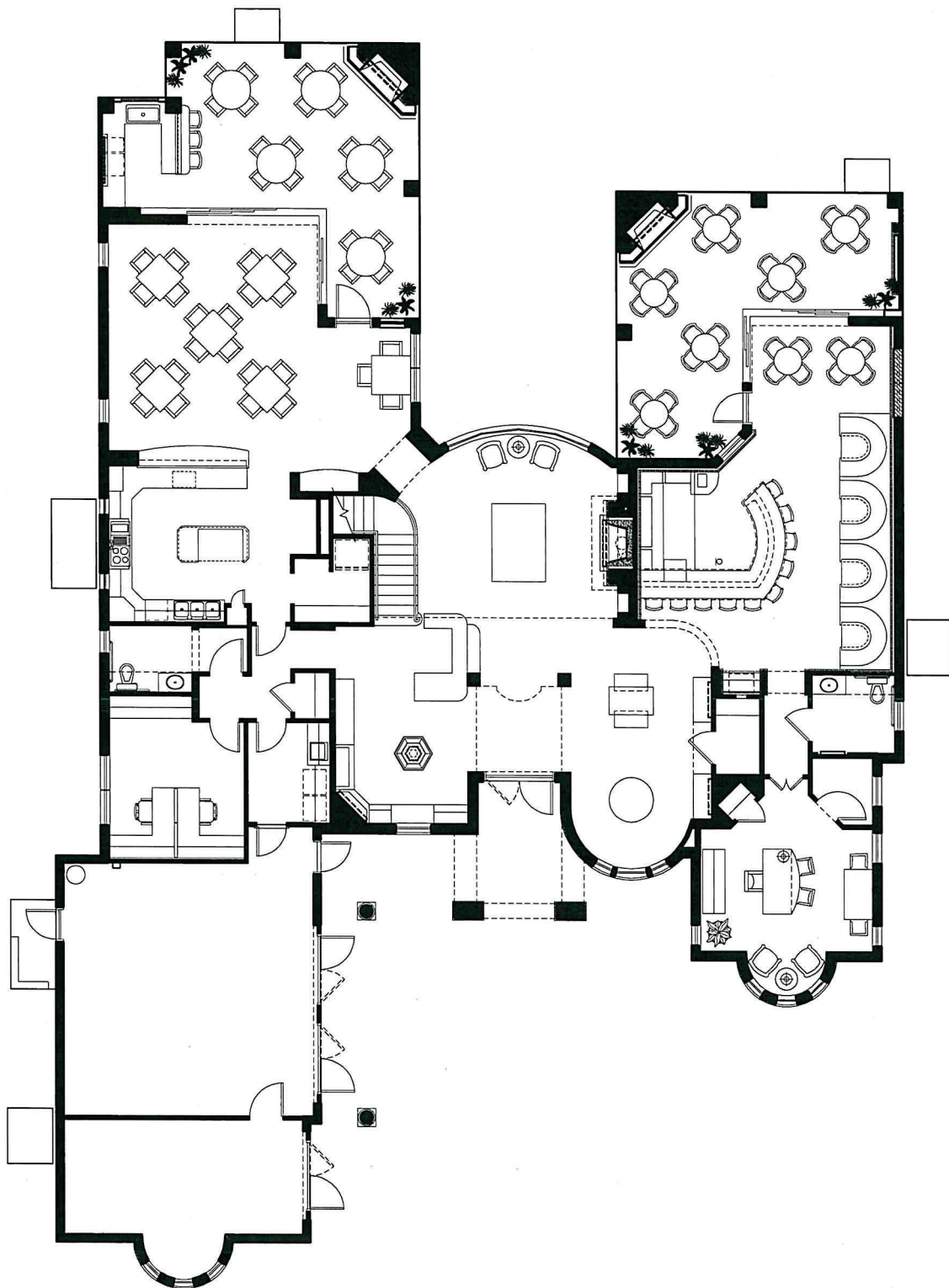

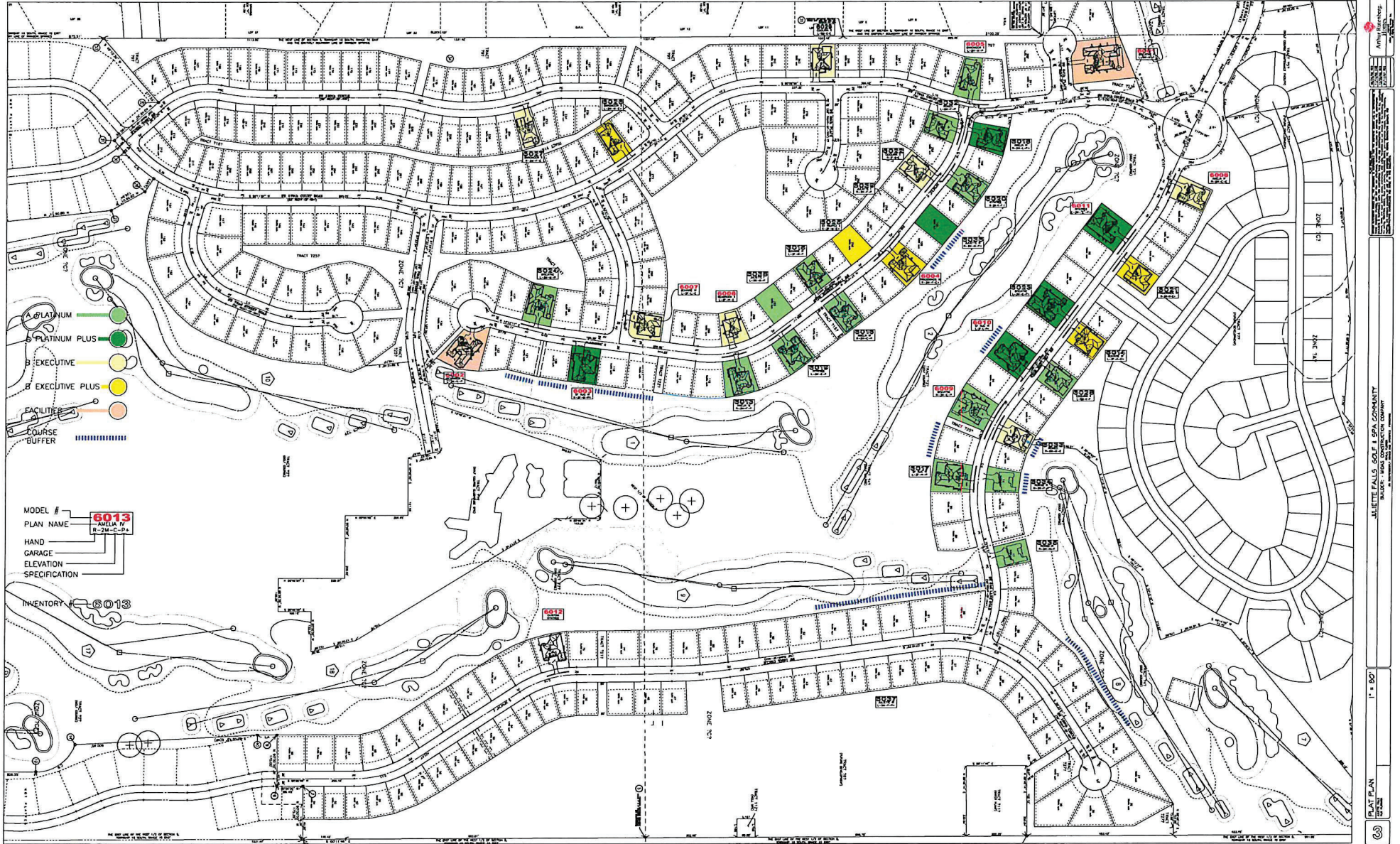


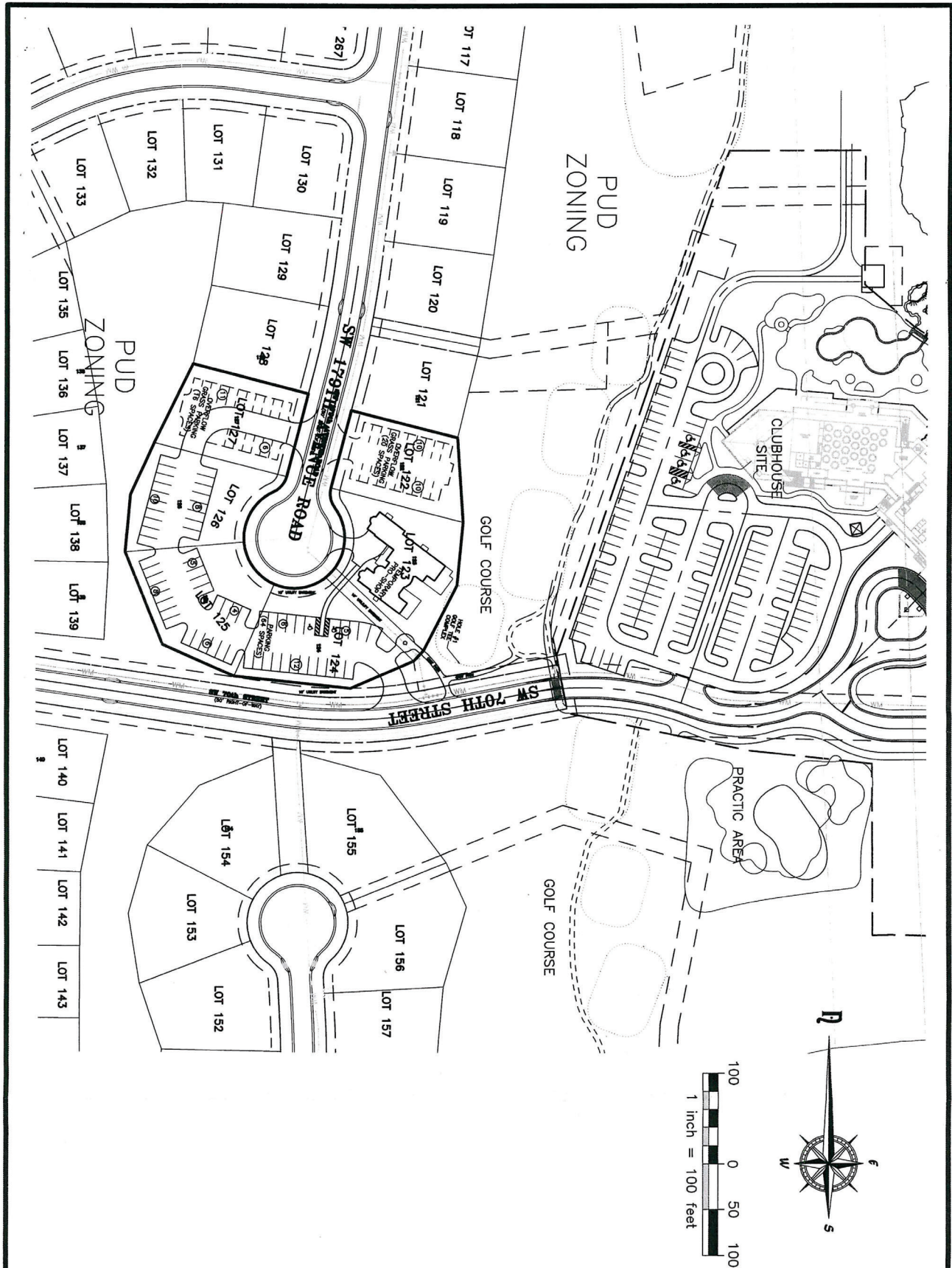
