However, the screening was denied, after reviewing the clerk of court records that indicate I have an outstanding housing balance related to my offense from 2014. I was aware and have paid other fees accumulated during the time of the offense. As it relates to the jail fees, I contacted the jail; I was advised that only Judge Hodges can waive or dismiss the fees attached. After several dead-end directions, I now understand the decision is at the discrepancy of the Board of County Commissioners. Today I am asking if you would consider the changes I have made and help me to pursue a more prosperous future.

Over 10 yrs. ago I was a young irresponsible girl in the car with 4 friends hanging out having what we thought was fun. A poor decision landed me with this offense and the fees attached have impacted my life greatly. Not only do I live day to day with this, but it has now become the deciding factor when it comes to how far I can go in life. I am now 36. I am a law-abiding citizen, a community leader, a responsible wife, married with 2 little boys. I do understand there are consequences for my actions. I served 6 months in Marion County Jail. I was a trustee and I also attended and completed the WEST Program while incarcerated. Since this time, I have had no encounters with the law. My actions have not only affected me, but also my kids. It saddens me for I feel I am not the best version of myself as a mom for them. I have been offered the opportunity to be the assistant Administrator at our church local Christian School. I would love the opportunity to support my church ministry, of which I am very much involved. The fees are just too much for me to bear. With your help I will be able to accept the position, for I am limited to what I can do when I know I have been called to do and to be more.
