If serving alcohol the business will require a food permit through the Department of Health in Marion County. 3	Special Use Permit	Stormwater is not opposed to the special use permit. The applicant is requesting a SUP for the purpose of a micro-distillery. Parcels 2091-008-002 & 2091-008-003 are currently zoned A-1 and are collectively 2.13 acres in size. There are no FEMA Flood Zones or County Flood Prone Areas on this site. Per the MCPA, parcel 2091-008-002 currently has 0 SF of impervious coverage while parcel 2091-008-003 currently has 6,244 SF of impervious coverage. This site will be subject to a Major Site Plan or waiver when the existing and proposed impervious coverage of either parcel exceeds 9,000 SF.	INFO	ENGDRN

4	Special Use Permit	2/19/25 - Recommend Reject: Unpaved road is inconsistent with commercial enterprise described which includes a distillery, a tasting room, and a gift shop. The "plant" is 3,298 square feet and according to the ITE Trip Generation Manual, 11th Edition, a Brewery Tap Room (Land Use Code 971), would generate an average weekday maximum peak hour trip of 36 and a daily average of 403 trips on a Saturday. If the SUP is approved, traffic recommends the following as a condition of approval: Applicant shall provide a paved route from the end of the paved section of SW 27th St continuously to the project driveway and shall submit an improvement plan for that construction for review and approval through the DRC process.
