## INCIDENT REPORT

12/28/23 08:42 JLC- I, ACC Correnti, along with mitigation specialist Hunyadi arrived at 2735 SE 140th Pl and met with Brett and Kim Woller. They allowed us on to the property.

Outside we observed two dogs:

“Granite” male white Great Pyrenees

“Siren” female white Great Pyrenees

Both dogs appeared in adequate condition. “Siren” get tethered when she is outside or she escapes the yard. There is a camera on her for observation and is brought inside when no one is home.

We observed several goats and chickens as well. There was a barn that had two stall converted, one for the baby goats and one for the Pyrenees to use as a shelter. There is a large play yard attached to the side of the house which at this time had no dogs in it.

We were then escorted inside the home which was clean and free of urine and feces. In the main part of the home, we observed the following dogs all to appear in adequate condition:

lagotto romagnolo:

“Rolo” male white/brown

“Olaf” male white/orange

“Castiel” male roan

“Blaze” female orange/white

“Porcia” female roan (mother to the three puppies)

“Bentley” neutered brown/white

“Salle” female white/brown

“Tito” male tri

3 four month old white/orange (available for sale)

“Cookie” female fawn russian tsvetnaya bolonka

Jackson” male fawn russian tsvetnaya bolonka

In a separate room there were several dogs crated (later observed in the run area). All crates were clean and free of feces and all dogs appeared in adequate condition. There was a note on each crate with instructions and who the dogs are able/not able to go outside with.

We observed the following lagotto romagnolo:

“Ella” female white

“Pheonix” F Roan

“Stormie” white/orange

“Maverick” M white/brown

“Remi” female brown/white

“Sig” female white/orange

Two dogs that were not present belong to their daughter and were with her:

“Kelly” female white Maltese/bichon

“Natalia” female brown russian tsvetnaya bolonka

At this time, the cruelty is unfounded. We spent time going over the kennel license. They provided me with a packet containing vaccine/county license information for the dogs. I was also provided with a binder which is what is given to each new puppy owner.

They did discuss one female dog that had gone into labor and had to be taken to the emergency vet in which they did

loose a puppy; however, that was not recently.

They had a copy of the kennel application completed but were unable to make an additional copy (came out blank on their printer). At this time, I advised them to hang on to it and submit it with the packet they had prepared for growth services.
