THIRD AMENDMENT TO WATER TOWER LICENSE AGREEMENT

This Third Amendment to Water Tower License Agreement (the "Amendment") is dated effective as of the _____ day of ______, 2024 (the "Effective Date") by and between Marion County, Florida, a political subdivision of the State of Florida, located at 601 SE 25th Avenue, Ocala, Florida 34471 (hereinafter designated "LICENSOR"), and Cellco Partnership d/b/a Verizon Wireless, with its principal offices at One Verizon Way, Mail Stop 4AW100, Basking Ridge, New Jersey 07920 (hereinafter designated "LICENSEE"). LICENSOR and LICENSEE are at times collectively referred to hereinafter as the "Parties" or individually as the "Party."

WITNESSETH:

WHEREAS, Licensor and Licensee, as successor by operation of law to Verizon Wireless Personal Communications LP, a Delaware limited partnership d/b/a Verizon Wireless, are parties to that certain Water Tower License Agreement dated April 5, 2005 (the "Original Agreement"), as amended by that certain First Amendment to Water Tower License Agreement, dated July 3, 2012 (the "First Amendment"), as further amended by that certain Second Amendment to Water Tower License Agreement, dated April 17, 2018 (the "Second Amendment", and together with the Original Agreement, and First Amendment, the "Agreement") wherein Licensor licensed to Licensee a portion of that certain space on the Licensor's water tower ("Tower") 493 Oak Road, Ocala, Marion County, Florida 34472 (the "Premises");

WHEREAS, Licensor and Licensee desire to amend the Agreement as hereinafter set forth;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Licensor and Licensee agree to the following:

- 1. From and after the date hereof, Exhibit A-2, Pages 2 and 3, attached to the Agreement are hereby deleted and replaced with Exhibit A-3, Pages 2 and 3, attached hereto and incorporated herein.
- 2. From and after the date hereof, Exhibit B-2 attached to the Agreement is hereby deleted in its entirety and replaced with Exhibit B-3 to this Third Amendment and Licensee shall be allowed to make the equipment additions or removals necessary to configure Licensee's equipment as shown on Exhibit B-3 of this Third Amendment.
- 3. The parties acknowledge and agree that Licensee's equipment modifications provided by this Third Amendment will increase the monthly rental to \$2,824.75 per month, beginning January 31, 2025.
- 4. Unless otherwise provided herein, all defined terms shall have the same meaning as ascribed to such terms in the Agreement.




