MARION COUNTY HISTORICAL COMMISSION APRIL 14, 2025

Roosevelt Village: Mrs. Long visited the walking trail at the Sheriff's Substation at 441/SW 80th St, and observed the informational display in the wooded area there, "The Island." Discussion of placement at substation property. We need a word count on the proposed text for the marker. Motion by Mrs. Long, seconded by Mrs. Delk, to put the marker at the entrance to the trail; all were in favor.

No invoice has been received for the Emerson School historical marker as of now.

Donated items: Mr. Richards moved, Dr. Cardinali seconded, to accept the items as listed, and to loan them back to the museum for research, cataloging, and display or archiving as deemed best.

Mr. Richards was asked how his invoicing is being taken care of. He will be invoicing \$500.00 for each of the living history videos, presenting them monthly for July, August and September.

Mr. Richards is following up with the Mayor's office regarding the proposed Newt Perry plaque. Mr. Richards hopes to have this lined up for early next year to be revealed.

Mrs. Wilson-Graham moves a marker be planned for the Santos community, to be placed at the county owned park there. Mrs. Long seconded, and the motion carried.
